**FOR FILLIES, THREE YEARS OLD** No Nomination Fee., \$500 to pass the entry box, \$500 to Start. Supplemental Nominations of \$2,000 will be accepted at time of entry which shall include all fees. The purse to be distributed; \$1,000 to all starters; with the balance of the purse to be divided, 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Any horse running and finishing in The Penn Oaks will automatically be nominated to the (1), 2014 running of the Charles Town Oaks at Charles Town; and (2), the Zia Parks Oaks at Zia Park. Weights: 121 lbs. Non-Winners of a Sweepstakes at a mile or over on the turf in 2013-2014, allowed 2 lbs.; \$45,000 twice at a mile or over in 2014, 4 lbs.; \$60,000 once at a mile or over in 2014, 6 lbs. (Maiden and Claiming races not considered in estimating allowances). (Preference to starters will be in the following order: First Preference will be to Graded Stakes or Group Winners in 2013-2014 in North America, Europe and Asia; Second Preference to Stakes Winners and Graded Stakes or Group Placed horses in 2013-2014 in North America, Europe and Asia; Third Preference to horses with the highest total earnings in Non-claiming races in 2013-2014). Starters to be named through the entry box on Wednesday, May 28, 2014. Principle/primary owner, trainer and jockey will receive points in accordance with the 2014 Penn Gaming Challenge scoring format.
