

OFFICIAL RULES AND REGULATIONS:

1. **ELIGIBILITY:** Must become a mychoice® member and at least twenty-one (21) years of age or older to participate in the Hollywood Casino at Penn National Race Course Coin Exchange Program (hereinafter the “promotion”). Employees of Penn National Gaming, Inc. its related companies, affiliates and subsidiaries, immediate family members of employees of Penn National Gaming, Inc. that are directly involved in the execution of the promotional event, and all persons listed on any Pennsylvania or Hollywood Casino at Penn National Race Course (“HCPN”) Exclusion and/or Self Exclusion list(s) are ineligible to participate.
