The Hollywood Jackpot High Five

The Hollywood Jackpot High Five Jackpot (Pentafecta), is a \$.20 wager that is divided into a major and a minor (carryover) pool. The major pool is divided among all tickets correctly selecting the first five finishers of the race in exact order. The minor pool is awarded when only one unique \$.20 wager correctly selects the first five finishers in exact order. If more than one ticket correctly selects the first five finishers in exact order, the minor pool is then carried over and placed in the minor pool of the next Pentafecta Race, unless the race has been designated a "Mandatory Payout Race". If no tickets correctly select the first five finishers in exact order, then the entire pool (major and minor) carries over to the minor pool of the next Pentafecta race.

Distribution of Winning

The net Jackpot Pentafecta pool shall be distributed in the following precedence, based on the official order of finish:

- A. As a single price pool (inclusive of any carryover pool) to the holder of the unique winning \$.20 wager whose combination finished in the correct sequence as the first five betting interest, but if there is no such unique winning \$.20 wager, then
- B. The net pool will be divided into two separate pools. The minor pool of the net pool shall be paid as a carryover pool into the next regularly scheduled Jackpot Pentafecta race. The remaining major pool shall be as a consolation pool, which will be equally divided among those ticket holders who correctly selected the first five interests, but if there are no such wagers, then
- C. The entire net pool shall become a carryover pool into the next regularly scheduled Pentafecta race.

A Unique winning wager shall be defined as having occurred when there is one and only one \$.20 winning wager whose combination finishes in the correct sequence as the first five betting interest. In the event that there is more than one winning \$.20 wager whose combination finished in the correct sequence as the first five betting interests, the unique winning wager shall be deemed to not have occurred.

Mandatory Distribution

A. An association may distribute a Pentafecta pool that includes a carryover on a specified race date at their sole discretion, but must provide notice to the Bureau Director of the PA SHRC and the betting public at least two weeks prior to the date of the distribution.

- B. Should the Pentafecta carryover be designated for distribution on a specified date in which there are no unique wagers whose combinations finished in correct sequence as the first five betting interests, the entire pool shall be distributed as follows:
 - 1. As a single price pool to those who combinations finished in the correct sequence as the first five betting interests, but if there are no such wagers, then
 - 2. As a single price pool to those whose combination included, in correct sequence, the first four betting interests, but if there are no such wagers, then
 - 3. As a single price pool to those whose combination included, in correct sequence, the first three betting interests, but if there are so such wagers, then
 - 4. As a single price pool to those whose combination included, in correct sequence, the first two betting interests, but if there are no such wagers, then
 - 5. As a single price pool to those whose combination included, in correct sequence, the first place betting interest only, but if there are no such wagers, then
 - 6. The entire pool shall be carried over to the next corresponding Pentafecta wager, consistent with the distribution methods described in section C.
- C. If for any reason, the Pentafecta pool distribution does not take place on a designated day, the Pentafecta carryover must be held over and distributed on the next racing day that offers a corresponding Pentafecta wager. If the next racing day that offers a corresponding Pentafecta wager is not within 30 calendar days of the designated Pentafecta pool distribution, the carryover pool shall be deposited in an interest bearing account. The Pentafecta carryover, plus accrued interest shall then be added to the net Pentafecta pool of the next corresponding Pentafecta wager.

Scratches

In the event that any contestant that is not part of an entry or field is scratched, all wagers including the scratched betting interest shall be refunded.

Dead Heats

- A. If there is a dead heat for first involving:
 - Contestants representing five or more betting interests, all of the wagering combinations selecting five betting interest that correspond with any of the betting interests involved in the dead heat shall share in the profit split.
 - 2. Contestants representing four betting interest, all of the wagering combinations selecting the four dead heated betting interest, irrespective of order, along with the fifth place betting interest, shall share in the profit split.
 - 3. Contestants representing three betting interests, all of the wagering combinations selecting the dead heated betting interest, irrespective of the order, along with the fourth and fifth place betting interest shall share in the profits.

- 4. Contestants representing two betting interest, both of the wagering combinations selecting the two dead heated interest, irrespective of order, along with the third, fourth and fifth place betting interest shall share in the profit split.
- B. If there is a dead heat for second involving:
 - 1. Contestants representing four or more betting interest, all of the wagering combinations correctly selecting the four dead heated betting interest shall share in the profit split.
 - Contestant representing three betting interest, all of the wagering combinations correctly selecting the three dead heated betting interests, irrespective of order, and the fifth place betting interests shall share in the profit split.
 - 3. Contestants representing two betting interests, all of the wagering combinations correctly selecting the two dead heated betting interests, irrespective of order, and the fourth and fifth place betting interest shall share in the profit split.
- C. If there is a dead heat for third involving:
 - 1. Contestants representing three or more betting interest, all of the wagering combinations correctly selecting the three dead heated betting interest irrespective of order shall share in a profit split.
 - 2. Contestants representing two betting interests, both of the wagering combinations selecting the two dead heated betting interests, irrespective of order, along with the place betting interest shall share in the profit split.
- D. If there is a dead heat for fourth, all wagering combinations correctly selecting the first three finishers, in correct sequence, along with any two of the betting interests involved in the dead heat for fourth shall share in the profit split.
- E. If there is a dead heat for fifth, all wagering combinations correctly selecting the first four finishers in correct sequence, along with any betting interests involved in the dead heat for fifth shall share in the profit split.

Minimum Field Size

- A. Pentafecta wagering shall not be scheduled on a thoroughbred or standard bred race unless at least eight betting interest are carded. In the event of a scratch, Pentafecta wagering on a race in which seven betting interests remain is permissible.
- B. If a races scratches below 7 betting interest, the pool wagered on that race shall be refunded.
- C. Upon approval of the stewards, this sections shall not be applicable on any day with a mandatory payout.

If fewer than five betting interests finish and the race is declared official, payoffs will be made based upon the order of finish of those betting interest completing the race. The balance of any selections beyond the number of betting interests completing the race shall be ignored. If the pools are being distributed

Pool Division – The take out for the Jackpot Pentafecta shall be 20%. The net pool shall be divided 60%
to the major pool and 40% to the minor carryover pool.

The Penn Jackpot Pick Six

The Penn Jackpot Pick Six ("Pick 6") is a \$.20 wager that is divided into a major and a minor (carryover) pool. The entire net Pick 6 pool and carryover, if any, shall be distributed to the holder of a unique winning ticket selecting the first place finisher in each of the selected six (6) contests, based upon the official order of finish. If there is no unique winning ticket selecting the first place finisher in all six (6) contests, the major pool of the net Pick 6 pool shall be distributed as a single price pool to those who selected the first place finisher in the greatest number of Pick 6 contests and the minor pool shall be added to the carryover.

"Unique winning ticket", as used in this subsection, shall be defined as having occurred when there is one and only one winning ticket that correctly selected the first-place finisher in each of the Pick 6 contests, based upon the official order of finish, to be verified by the unique serial number assigned by the tote company that issued the winning ticket. In the event that there is more than one winning ticket that correctly selected the first-place finisher in each of the Pick 6 contests, based upon the official order of finish, the unique winning ticket shall be deemed to not have occurred.

If there is a dead heat for first in any of the Pick 6 contests involving:

- (1) Contestants representing the same betting interest, then the Pick 6 pool shall be distributed as if no dead heat occurred.
- (2) Contestants representing two or more betting interests, then the Pick 6 pool shall be distributed as a single price pool with each winning wager receiving an equal share of the profit.

Should a betting interest in any of the Pick 6 contests be scratched, excused or determined to be a non-starter the actual favorite, as evidenced by total amounts wagered in the win pool at the host association for the contest at the close of wagering on that contest, shall be substituted for the scratched betting interest for all purposes, including pool calculations. In the event that the win pool total for two or more favorites is identical, the substitute selection shall be the betting interest with the lowest program number. If wagers on a scratched horse(s) transferred to the post time favorite creates two or more winning combinations on a single ticket, as audited by the totalizator service provider of the host association, the ticket shall be deemed a single winner and the holder of the ticket shall be entitled to the entire net pool, including the minor (carryover) pool. The totalizator shall produce reports showing each of the wagering combinations with substituted betting interests which became winners as a result of the substitution, in addition to the normal winning combination.

The Pick 6 pool shall be cancelled and all Pick 6 wagers for the individual performance shall be refunded if at least three contests included as part of the Pick 6 are cancelled or declared "no contest"; or, if at least one contest included as part of the Pick 6 is canceled or declared "no contest," but not more than the number specified above of this rule, the net pool shall be distributed as a single price pool to those whose selection finished first in the greatest number of Pick 6 contests for that performance. Such distribution shall include the portion ordinarily retained for the Pick 6 carryover but not the carryover from previous performances.

The Pick 6 carryover may be capped at a designated amount approved by the commission so that if, at the close of any performance, the amount in the Pick 6 carryover equals or exceeds the designated cap, the Pick 6 carryover will be frozen until it is won or distributed under other provisions of this rule. After the Pick 6 carryover is frozen, one hundred per cent of the net

pool, part of which ordinarily would be added to the Pick 6 carryover, shall be distributed to

those whose selection finished first in the greatest number of Pick 6 contests for that

performance.

Should the Pick 6 carryover be designated for distribution on a specified date and performance in which there are no wagers selecting the first place finisher in each of the Pick 6 contests, the entire pool shall be distributed as a single price pool to those whose selection finished first in the greatest number of Pick 6 contests.

If, for any reason, the Pick 6 carryover must be held over to the corresponding Pick 6 pool of a subsequent meet, the carryover shall be deposited in an interest bearing account approved by the commission. The Pick 6 carryover plus accrued interest shall then be added to the net Pick 6 pool of the following meet on a date and performance approved by the commission.

With the written approval of the commission, the permit holder may contribute to the Pick 6 carryover a sum of money up to the amount of any designated cap.

Pool Division – The take out for the Jackpot Pentafecta shall be 20%. The net pool shall be divided 60% to the major pool and 40% to the minor carryover pool.
