FOR FILLIES, THREE YEARS OLD No Nomination Fee., \$1,000 to pass the entry box, \$1,000 to Start. Supplemental Nominations of \$3,000 will be accepted at time of entry which shall include all fees. The purse to be distributed; \$2,000 to horses finishing 6th through last place; with the balance of the purse to be divided, 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weights: 122 lbs. Non-Winners of a Sweepstakes at a mile or over on the turf, allowed 2 lbs.; \$45,000 twice at a mile or over in 2018, 4 lbs.; \$45,000 once at a mile or over in 2018, 6 lbs. (Maiden and Claiming races not considered in estimating allowances). This race will be limited to twelve (12) horses. Preference to starters will be in the following order: First Preference will be to Graded Stakes or Group Winners in North America, Europe and Asia; Second Preference to Stakes Winners and Graded Stakes or Group Placed horses in North America, Europe and Asia; Third Preference to horses with the highest total earnings in non-claiming races. Starters to be named through the entry box by the usual time of closing.
