“Monday and Thursday Night Football Promotion”

OFFICIAL RULES AND REGULATIONS:

1- On Monday December 3rd, 10th, and 17th AND Thursday 6th and 13th the Poker Room at Hollywood Casino at Penn National Race Course will host a football promotion where we will run a High Hand during specific football games for \$1000 quarterly High Hand for each quarter of the football game.

- **Football Promotion (High Hands):** The qualifying period opens at opening kickoff of the designated football game. One - \$1000 winner is announced at the completion of each quarter of the designated football game for a total of four High Hand periods, a Poker Supervisor announces the qualifying period is complete. Dealers will finish the hand they are on and then press the call button to signify they are finished. Any hand in process before the call button is pressed is eligible. A hand in play after the call button is pressed will qualify for the next quarter of the designated football game. Once all service buttons have been pressed signifying the round is completed, they will be reset for the next round.

2- During each qualifying period, Poker Supervisor will announce the opening of the new qualifying periods. The qualifying periods will run as follows.

- Qualifying Period 1: Opening kickoff to end of first quarter.
- Qualifying Period 2: Completion of Period 1 through end of second quarter.
- Qualifying Period 3: Completion of Period 2 through end of third quarter, this includes halftime.
- Qualifying Period 4: Completion of Period 3 through end of fourth quarter, overtime does not count as a new period or a continuation of qualifying period 4.

3- Football promotion is posted in the HCPN Poker Room at least 48 hours prior to the selected promotion date.

4- At the completion of the qualifying period, a Poker Supervisor announces the qualifying period is complete. Dealers will finish the hand they are on and then press the call button to signify they are finished. Any hand in process before the call button is pressed is eligible. A hand in play after the call button is pressed will qualify for the next qualifying period. Once all service buttons have been pressed signifying the round is completed, they will be reset for the next round.

5- The opening high hand and subsequent higher hands are verified by a Poker Supervisor or above and posted on a television screen inside the Poker Room.

6- In the event the television display is inactive, the high hand updates are verbally announced on the overhead speakers. A High Hand Tracking Log is completed to track the player's hand and table number.

7- At the completion of each qualifying period, the Poker Supervisor visits the location of the winner. Each winner receives and completes a Poker Room Promotion Slip. Winners have 24 hours to produce their ID and claim their prize. Failure to claim the prize or produce ID within 24 hours results in forfeiture of the prize. HCPN will make one effort to contact the guest by phone in the event they are not present.

8- The minimum qualifying hand is a full house, Jacks full of Deuces. For a hand to qualify at least four players must have been dealt in the hand and the pot total would have to reach at least \$10. Patrons must use both of their hole cards in determining the high hand. A player's kicker must beat or tie the best kicker on the board in a situation of a Four of a kind without a pocket pair.

9- A qualifying high hand is not required to reach the showdown.

10- All hands must be clearly displayed.

11- Winning Marquee Rewards members will be awarded their prize by being issued a "Poker Room Promotion" payout voucher by Hollywood Casino staff. Winning Marquee Rewards members must redeem their prize at Player Services. All prizes will be paid from the "Player Pool Promotional Fund."

12- In the event that the same two or more qualifying hands are made within the same qualifying period, the prize is divided evenly amongst those qualifying hands.

13- On promotion days, only 1 dinner break will be given per table. All other players will be bagged after 10 minutes. This rule will be enforced three hours prior to the start of the promotion.

14- Winners are responsible for any Federal or State income taxes on all prizes. Hollywood Casino is not responsible for lost or stolen prizes after the prize is claimed.

15- By participating in the event you grant Mountainview Thoroughbred Racing Association, d/b/a Hollywood Casino at Penn National Race Course, its representatives, assigns and transferees the right to photograph and/or take video of you. You further authorize the use of your likeness or image for print and/or video, with or without your name, for publicity, illustration, advertising and Web content to promote the Hollywood Casino at Penn National Race Course as they see fit. Participating Marquee Rewards members further agree that they will not receive any compensation for the use of their likeness or image described above.

16- Employees of Hollywood Casino, its related companies, affiliates and subsidiaries and all persons listed on the Pennsylvania and Hollywood Casino at Penn National Race Course Exclusion and/or Self Exclusion list(s) are ineligible to participate.

17- Hollywood Casino at Penn National Race Course is the host and sole judge of the giveaway and reserves the right to change, cancel, or modify this promotion at any time without notice. Hollywood Casino will not be held responsible in the event of typographical errors or misinformation on the Hollywood Casino website or printed materials pertaining to this event, and players will have no claim in these matters. Any dispute or situation not covered by the official rules will be resolved by Hollywood Casino management in a matter

deemed by them to be the fairest to all concerned, and that decision shall be final and binding on all participants.
